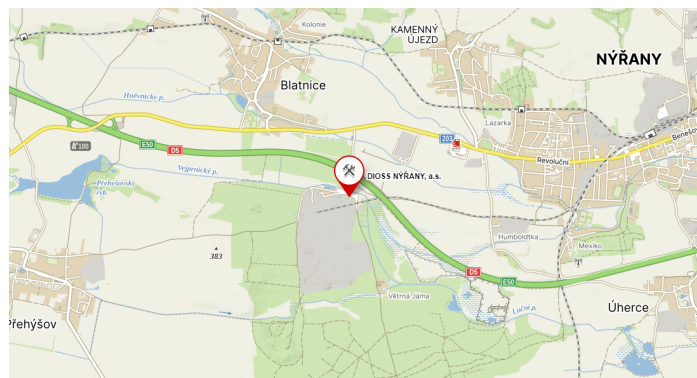

Welcome to our company, and in the interest of protecting your health, please pay attention to the following message.

Throughout our company, the following applies:



No smoking allowed.

(Smoking only in designated areas)



No photography allowed.

(Photography only with explicit consent)

Open-toed shoes (pumps, sandals), shorts, skirts, sleeveless shirts (must have at least short sleeves) are prohibited in production areas.



Entry to production areas is prohibited without these protective equipment. (Further specified at the entrance to each hall) .

The maximum permitted speed throughout the premises is 20 km/h.



The most serious risks danger

- Danger from **internal traffic** (forklifts, freight, delivery, and passenger vehicles)
- Danger arising from the **use of cranes and similar lifting equipment** - storage and handling of heavy and oversized loads."
- **At workplaces with gas equipment, risks associated with inhaling the particular gas**, risks associated with the properties of the particular gas.
- At workplaces with **excessive noise or dust, the possibility of health** damage from these risk factors
- **Danger of potential falls on a flat surface** (unevenness on the floor, short-term storage of objects on the ground). **Potential falls from height or depth** (work at a height above 150 cm).
- **Danger of fire and subsequent burns.**
- **Danger of entanglement with machinery** (combined risk - from minor to fatal health damage).
- **Danger of eye injury and burns from welding of metals .**
- **Possible chainsaw, brushcutter, lawnmower injuries.**

Additional rules for visitors

- Always inform the receptionist of your visit, wear the 'VISITOR' badge visibly.
- In production areas, move only accompanied by a company employee.
- Always move along designated paths.
- Follow the instructions given by safety signs.

- In case of fire or evacuation, follow the instructions of the escort.
- Do not bring alcoholic or narcotic substances into the company premises, and do not enter the company premises under the influence of alcohol or narcotics.

Additional rules for suppliers and transport

- Respect the instructions of company management members, company personnel designated as responsible individuals (authorized representatives, persons responsible for OH&S) .
- Commence work each day only after contacting the authorized representative and/or the operations manager, or after receiving written permission from the authorized representative.
- Respect the instructions of the operations managers, foremen, in whose departments they perform agreed tasks or operate.
- Do not bring alcoholic and narcotic substances into the company premises.
- Do not enter the premises under the influence of alcohol or narcotics.
- In case of suspicion of alcohol or narcotic substance consumption, submit to a preliminary breath test administered by the authorized representative of the company management or undergo medical examination if necessary.
- Subject oneself to random vehicle and luggage inspections.
- Any work in the company premises may only be carried out by employees who meet the requirements for professional competence or qualification and are medically fit for the given task.
- Employees of the supplier are required to have the necessary permits authorizing specific activities with them.
- It is not allowed to obstruct escape routes and exits, electrical distribution equipment, control panels, closures and fittings, portable or movable fire extinguishing devices, with any stored material.
- Familiarize yourself with the Alarm Directives before commencing work.
